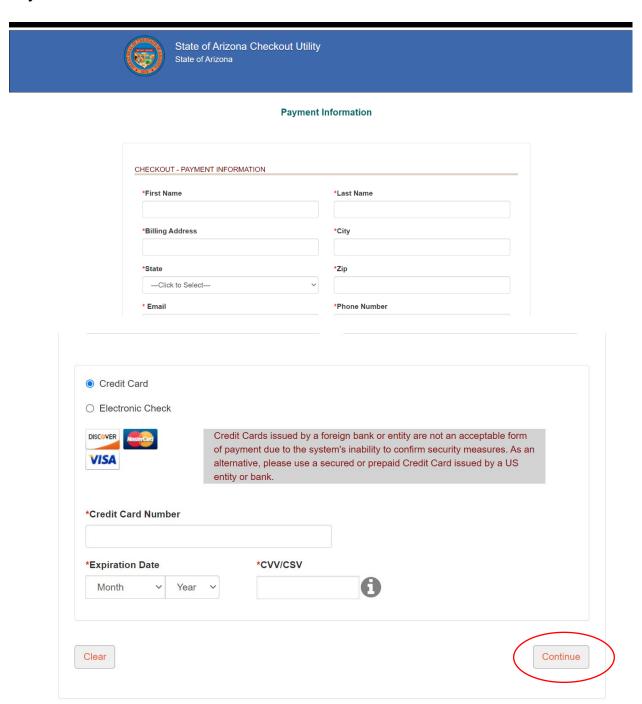
Payment Detail

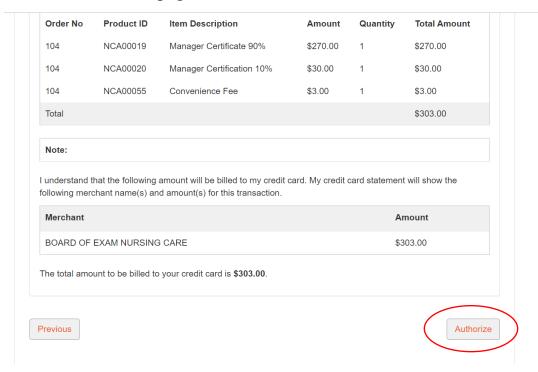
Then select submit

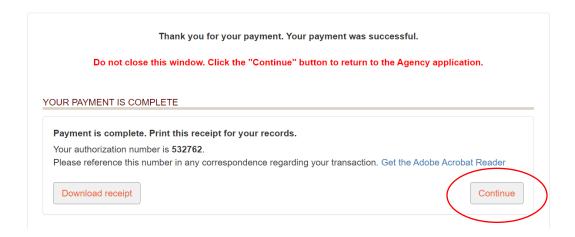
### Scroll to the bottom of the page and click Authorize



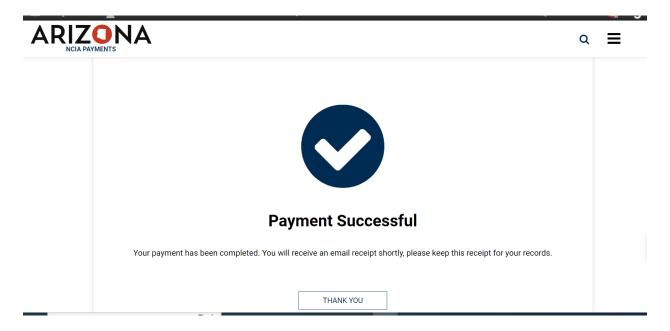
When you have Authorized the payment, you will be taken to the receipt page. Press Continue.
